PARS is a secure online service that allows authorized account holders to receive driver and/or vehicle record abstracts quickly and easily using the web. Employer Notification within PARS is free to sign up for and free to use – and provides notifications for any changes to an employee's driving record, and any changes/updates related to tier of operation changes and Fed Med card expiration.

The State of Wisconsin and the Division of Motor Vehicles have entered into an agreement with

Wisconsin Interactive Network. The purpose of this agreement is to develop Wisconsin's new eGovernment website portal. PARS has migrated to the new website portal as of Nov. 1, 2013. **PARS is available through the DMV data portal provided by Wisconsin Interactive Network.**
