Issued for certain vehicles used to transport disabled or elderly persons in connection with any


DOT transportation assistance program. Must have insurance filed with DOT.

Low-speed vehicle (LSV)

Issued for low-speed vehicles (LSV) that meet National Highway traffic Safety Administration standards and have a certification label stating that the vehicle meets those standards. May be self-propelled by gas or electric engine. A golf cart is not considered an LSV.  [More...](#)

Motor home

Issued for motor homes (a motor vehicle designed to be operated upon the highway for use as a temporary or recreational dwelling). Two distinct plate styles are valid if currently registered.

Registration period	1 year or quarterly
Plate expiration	March 31 for annual registration; March 31, June 30, September 30 or December 31 for quarterly registration.
Fee	Based on vehicle gross weight (see fee chart). Can only be personalized for additional \$15 per year with yearly registration.
Number of plates	Two
Plates remain with	seller
Personalized available?	Yes, for an additional \$15 per year (annual registration only)
Plate color	Black on white graphic beginning in 2005 (red on white graphic prior to 2005)

Recreational vehicle trailer (including camping trailer)

Issued for a vehicle being towed as a single unit or in sections upon a highway by a motor vehicle (has rigid walls and is equipped and used primarily for human habitation). If over 45 feet, requires a special permit to operate on roadways. Two plate configurations are valid if currently registered.

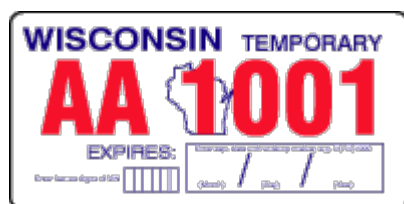
