Licenses revoked for area wholesale dealers

The Wisconsin Department of Transportation Division of Motor Vehicles (DMV) protects consumers by ensuring vehicle dealers meet eligibility requirements and follow Wisconsin's laws. After recent investigations and reviews, DMV revoked the wholesale dealer licenses of these Columbia County dealers, located at 101 Skyline Drive, Arlington, for failing to properly follow administrative requirements.

DMV's Dealers and Agents Section determined that each dealer listed violated state law when they failed to maintain a licensed business facility. Through investigations and numerous attempts to reach them, DMV determined that the dealers abandoned their locations. This is in violation of state law and a requirement to maintain their license.

The license revocations took effect May 8, 2020:
