Wisconsin Department of Health Services Section 1115 SeniorCare Prescription Drug Assistance Program Waiver Amendment

Overview

The Department of Health Services (DHS) intends to submit an application to the Centers for Medicare & Medicaid Services (CMS) requesting an amendment of its section 1115 research and demonstration project waiver, known as the SeniorCare Prescription Drug Assistance Program.

Through a section 1115 demonstration waiver amendment, Wisconsin seeks to expand the pharmacy benefits for individuals who qualify for SeniorCare to include vaccination coverage. In addition, by expanding access to vaccinations for the elderly, Wisconsin will continue to provide a needed health care benefit to low-income seniors.

This Wisconsin SeniorCare Prescription Drug Assistance Program waiver extends Medicaid eligibility through Title XIX to cover prescription drugs, including vaccinations, as a necessary primary health care benefit. The target population for services under the SeniorCare is seniors who are age 65 or older with income at or below 200 percent of the federal poverty level (FPL), which is \$25,520 for an individual and \$34,480 for a two-person family in 2020.

Public Comment

By law, you have the opportunity to review the official full public notice and waiver extension application and provide comments from October 19 through November 2, 2020.
