INITIAL REGULATORY FLEXIBILITY ANALYSIS. This rulemaking will not affect small businesses. The Wis. Stat. § 227.114 (12) definition of "small business" states that to be considered a small business, the business must not be dominant in its field. Since gas utilities are monopolies in their service territories, they are dominant in their field and are not small businesses. Further, the contract between the U.S. Department of Transportation, Pipeline and Hazardous Materials Safety Administration (PHMSA) and the Commission requires that treatment be uniform across the state and across gas pipeline operators. As a result, the Commission cannot make special provisions for small business.

WISCONSIN ENVIRONMENTAL POLICY ACT. This is a Type III action under Wis. Admin. Code § PSC 4.10 (3). The Commission has reviewed the potential environmental effects of the project. The proposed revisions will not result in possible significant adverse environmental or social impacts. The preparation of an environmental impact statement under Wis. Stat. §1.11 or an environmental assessment is not necessary.
