

## Notice of Preliminary Hearing on Statement of Scope

The Department of Natural Resources announces that it will hold a preliminary public hearing on Statement of Scope SS 053-21 relating to sturgeon spearing harvest regulations and gear use. In accordance with s. 227.136, Wis. Stats., the DNR is seeking public comment and feedback on Statement of Scope SS 053-21 at the time and virtual location shown below.

**Rule Information:** This is a statement of scope for a proposed emergency rule; no rules have yet been developed. The future rule may address the use of underwater cameras, electronic fish finders, and similar technology during the Winnebago sturgeon spearing season, and may remove the size limit for sturgeon during the spearing season.
