The Department of Corrections announces that it will hold a public hearing on Statement of Scope, SS 036-22, a statement of scope indicating the Department of Corrections' intent to engage in rulemaking to revise Chapter DOC 346, Wis. Adm. Code, relating to secure detention for juveniles.
