

## **Notice of Preliminary Public Hearing and Comment Period on Statement of Scope**

The Department of Financial Institutions announces that it will hold a public hearing on Statement of Scope SS 081-23, a statement of scope indicating the Department of Financial Institutions' intent to engage in rulemaking to revise DFI-CU chs. 51-75, Wis. Adm. Code, relating to correcting out-of-date cross-references, repealing obsolete provisions, modifying the structure of existing rules to conform to current drafting practices, and revising the definition of "member business loan" to conform to federal law. In accordance with s. 227.136, Stats., the Department of Financial Institutions will hold a public hearing and receive public comments regarding the proposed rulemaking as described in SS 081-23, as follows, at the time and place shown below.
