The Department of Corrections announces that it will hold a public hearing on Statement of Scope, SS 023-24, a statement of scope indicating the Department of Corrections' intent to engage in rulemaking to revise Chapter DOC 309, Wis. Adm. Code, relating to resources for inmates, specifically inmate mail.
