### Rule Information:

This rule will implement changes related to elk management and hunting regulations that have emerged from the Department's elk management plan. Some of the objectives from this plan may include name changes and boundary modifications of the elk ranges, population goal changes, the creation of elk hunting units and modification of the elk hunting season dates.
