Revised, modified, and corrected administrative code chapters are published in this Register. Repealed chapters of the administrative code are removed from the code on the first day of the first month following publication of this Register. In addition to the monthly updates listed below, the register published on November 25, 2024, features a wholesale republication of the administrative code. The republication is necessary to accommodate changes to pagination resulting from a transition to new publishing software used for document publication and to allow for the sunseting of the previous software. To accomplish the republication, each chapter and appendix of the administrative code has been designated for removal, to be replaced by an inserted version produced with the new software. Except for the chapters specifically listed below, the republished chapters do not include modifications from final rule orders or corrections under ss. 13.92 (4) and 35.17, Stats. In conjunction with the republication, the LRB has also discontinued the use of continuous page numbering across agency code chapters, and each republished chapter and appendix has been designated to start at page 1.
