The Wisconsin Department of Workforce Development (DWD) announces that, pursuant to s. 227.136 (1), Stats., a preliminary public hearing and comment period will be held regarding a statement of scope for proposed emergency and permanent rules revising Wis. Admin. Code ch. DWD 80 related to procedural rules for hearings and adjudicatory functions for worker's compensation cases and similar cases.
