**Chap 217** An act authorizing the Governor to draw the five per centum of the net proceeds of the public lands.

*THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

Gov. authorized to draw the five per cent. fund.

[SECTION 1.] The governor of this state is hereby authorized and empowered to receive from the treasury department of the United States, from time to time, as he shall see fit to draw for the same, the five per centum of the net proceeds of sales of the public lands, to which this state is or shall be entitled, pursuant to the act of congress, approved August sixth, 1846, and to execute the proper vouchers therefor; and when received, he shall pay the same into the state treasury to the credit of the school fund.

**Chap 218** An act to divide and organize the towns of Vienna and Westport.

*THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

Westport.

SECTION 1. Town eight, range nine, Dane county, is hereby organized into a separate town, by the name of Westport, and the first town meeting shall be held at the house of Michael Malaga, and the first election shall be held on the third Monday in April, 1849.

Vienna.

SEC. 2. That town nine, range nine, in Dane county, is hereby organized into a separate town by the name of Vienna, and the first town meeting shall be held at the house of Mr. Fisher in said town, on the third Monday of April next.

Elections how held.

SEC. 3. The elections in said towns shall be conducted in the same manner as other elections for town officers in towns, on their first organizations, and the officers so elected shall hold their offices

until the next annual election, and until their successors are elected and qualified.

SEC. 4. This act shall take effect from and after its passage.

An act to alter the boundaries of the town of Milford, in Jefferson county. **Chap 219**

*THE People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

SECTION 1. Sections twenty-five and thirty-six, in township number eight north, of range number thirteen east, in the county of Jefferson, are hereby annexed to the town of Milford, and made a part and portion of said town. **Annexed to Milford.**

SEC. 2. This act shall take effect and be in force from and after its passage.

An act authorizing certain suits in behalf of the State to be commenced in any county. **Chap 220**

*THE People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

SECTION 1. When it shall be necessary to commence a suit or any judicial proceedings against any county or any county treasurer to recover the amount of indebtedness to the state, either for state taxes not paid over, or for any other cause, such suit or legal proceedings may be commenced in any county in this state. **Suits commenced in any co. in state.**

SEC. 2. The secretary of state is requested to cause this act to be published immediately, and it shall take effect from and after its publication.
