

Chap. 231 An Act to authorise the construction of a bridge across Fox River at Grand Kaukalin.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

Who to build and maintain bridge.

SECTION 1. That George W. Lawe, David P. Meade and Clark Knight, their associates and assigns, be, and they are hereby authorised and empowered to build and maintain a bridge across Fox river, at some convenient point on the rapids at Grand Kaukalin in the county of Brown.

Draw to be built

SEC. 2. Said bridge shall not be less than twelve feet wide, and shall contain a draw over the most navigable channel of said river, of sufficient width to pass and re-pass all boats and water crafts free of charge and expense and without unnecessary delay.

Rates of Toll.

SEC. 3. The persons herein named, their associates and assigns, shall have power after the completion of said bridge to demand and collect tolls for passing the same as follows : for every vehicle drawn by one horse or mule, ten cents ; for every vehicle drawn by two horses, oxen or mules, twenty cents ; for each additional horse, ox or mule, five cents ; for every foot passenger, five cents, and for animals in droves, two cents each : Provided, sheep and hogs shall not be charged more than at the rate of one cent per head.

Proviso.

SEC. 4. The said persons herein named, their associates and assigns shall keep posted up in some conspicuous place on said bridge a list of the rates of tolls allowed by this act.

List of rates to be posted.

SEC. 5. This act may be amended, altered or repealed by any future legislature.

Chap. 232 An Act to provide for laying out a State Road from Menasha to Plover Portage.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

Commissioners appointed.

SECTION 1. That John Boyd, Lyman Fargo and David Sumner, are hereby appointed commissioners to lay out and establish a state road from Menasha to Plover in Portage county, by Fremont and the Little River Mills.

Supervisors may fix compensation.

SEC. 2. Said commissioners shall receive such sum for their services as the supervisors of the counties through which said road shall pass, may deem proper : Provided, That no money

shall be drawn from the State Treasury to pay for laying out said road.

An Act to authorise the laying out of a State road in the counties of Brown and Portage. Chap. 233

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. That J. Wakefield, John Stephens and H. Wilcox be and they are hereby appointed commissioners to lay out and establish a State road from some point on Fox river, near Appleton, in the county of Outagamie, to Muckwa on Wolf river, and from thence to Plover in Portage county. Commissioners appointed.
Route.

SEC. 2. The said commissioners shall receive, for the laying out said road, such compensation as the Supervisors of the several counties through which the said road shall run, may determine: Provided, that no monies in the State treasury shall be appropriated therefor. County Supervisors may determine compensation.
Proviso.

An Act to authorise the laying out of a State Road therein named. Chap. 234

The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

SECTION 1. That Wm. O. Giddings, John Nelson and David Humes, be, and they are hereby appointed commissioners to lay out and establish a state road commencing at or near the quarter line of section [—] in the town of Bloomingdale, in the county of Winnebago, thence north, on the most feasible route, to the village of Winneconna. Commissioners appointed.
Route.

SEC. 2. The said commissioners shall receive for the laying of said road such compensation as the supervisors of the said County Supervisors shall fix compensation.
