Chap. 258

An Act to amend Section twenty-eight of Chapter one hundred and thirty-one title twenty nine, of the Revised Statutes

The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

Compensation
of Jurors—who
to pay.

SECTION 1. Each juror sworn in any action in a Justice's Court or before any Sheriff, on any writ of inquiry shall be entitled to fifty cents for each days attendance, to be taxed against the losing party, and when in any action before a Justice of the Peace (except in criminal cases) any of the parties to the action shall demand a jury trial, such party shall before being entitled to the empannelling of a jury pay jury's fees for half a days' attendance in advance, and so much of said act as contravenes the provisions of this act be and the same is hereby repealed.

Chap. 259

An Act to authorise the construction of a dam across the Pecatonica River, in La Fayette County.

The People of the State of Wisconsin represented in Senate and Assembly do enact as follows:

Dam—who may
erect, &c.

SECTION 1. Samuel George, his associates, successors, heirs and assigns are hereby authorised to erect and maintain a dam across the Pecatonica river, on the north-west quarter of section number one, of town number two, north of range number three, east of the fourth principal meridian, in the county of La Fayette, and to make use of the water of said river for hydraulic purposes: Provided, That the construction of said dam shall in no way infringe upon the rights of other persons not herein named.

Proviso.

SEC. 2. The said dam shall not exceed eight feet in height

from the water mark, and shall be so constructed as to admit of the passage of all descending rafts or water crafts, and the said rafts and water crafts shall at any times be entitled to pass through the said dam free of all charges to the owner or owners of said rafts or water crafts.

SEC. 3. The legislature may at any time alter or amend this act, when it shall be considered proper to provide for the improvement of the Pecatonica river.

An Act to authorise the citizens of the village of Waucoma to build a meeting house on the public square of said village.

Chap. 260

The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows :

SECTION 1. The citizens of the village of Waucoma in the county of Rock, are hereby authorised to build a meeting house on the public square in the village of Waucoma in the county of Rock; said house shall be built by public subscription, and under the direction of three trustees elected by a majority of the stockholders to said meeting house; and when said [meeting house] shall be completed and ready for use, it shall remain free for any religious denomination, to hold their meetings therein.
