SEC. 2. Jacob Spaulding, Skyler Gates, and C. B. Strong are hereby appointed Commissioners to lay out and establish a state road from Black River Falls to the point on the Wisconsin river in Adams county, where the road mentioned in the first section of this act crosses the same. Commissioners appointed to lay out Road.

SEC. 3. If any of the Commissioners appointed by this act shall by any cause be unable to perform the duties hereby required, then and in such case they are hereby authorised to appoint a substitute: Provided that no part of the expense of laying out said roads shall be paid out of the State treasury. Commissioners to appoint substitutes

An Act to provide for laying out a State Road from Fort Atkinson to Palmyra in Jefferson county. **Chap. 273**

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. That Milo Jones, D. B. Peck and Zebiror Wilson be and they are hereby appointed Commissioners to lay out and establish a state road from Fort Atkinson in Jefferson county to Palmyra in said county. Commissioners appointed.

SEC. 2. No money shall be paid out of the state treasury for any service required by this act. State not to pay expense.

An Act to vacate a portion of the Plat of the village of Fond du Lac.

Chap. 274

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. That blocks numbered twenty-two, twenty-three, thirty-one, thirty-two, thirty-three, and fractional block thirty-four, together with all lots, streets, alleys and squares included in said blocks, in the Plat of the village of Fond du Declared vacated.

Lac in Fond du Lac county, are hereby declared vacated, and the owners thereof may possess all the rights and privileges that they did, or would have possessed in relation thereto, had not the same been laid out into village lots.

SEC. 2. This act shall take effect from and after its passage.

Chap. 275 *An Act to vacate a part of the Town Plat of the village of Westfield in Sauk county.*

The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

Declared vacated.

SECTION 1. All that part of the town plat of the village of Westfield in the county of Sauk, lying north of a line sixty-three rods south of the section line between sections one and twelve in township nine, north of range six east, and parallel with said line, except the east half of block fifty-five and blocks fifty-six and fifty-seven, is hereby vacated.

SEC. 2. This act shall take effect from and after its passage.

An Act to alter the boundaries of the town of Calumet in Fond du Lac county

Chap. 276 *The People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

Boundaries of Calumet.

SECTION 1. The south half of town seventeen, range eighteen, the south half of town seventeen, range nineteen, the north half of town sixteen, range eighteen, and the north half of town sixteen, range nineteen, in Fond du Lac county, shall constitute the town of Calumet, and elections in said town shall be held at the School House in school district number two of said town.

Boundaries of Forest.

SEC. 2. Town fifteen, range nineteen, and the south half of town sixteen, range nineteen, shall remain and constitute the town of Forest.

Boundaries of Taychedah.

SEC. 3. The south half of town sixteen and sections one, two, three, four, five and six of town fifteen, range eighteen, shall constitute the town of Taychedah.
