An Act to appropriate to Rood & Whitmore the sum therein named.

*The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

Sum appropriated.

SECTION 1. There is hereby appropriated to Rood & Whitmore to be paid out of any money in the treasury not otherwise appropriated, the sum of four hundred and twenty-nine dollars and eighty cents in full payment for stationery, furnished State officers.

## Chap. 366

An Act to appropriate to C. Latham Sholes a sum therein named:

*The People of the State of Wisconsin represented in Senate and Assembly do enact as follows:*

Sum appropriated.

SECTION 1. There is hereby appropriated to C. Latham Sholes, out of any money in the treasury not otherwise appropriated, the sum of three thousand dollars (\$3000 00), in part payment for printing the journals of the Senate and Assembly of the Legislature of the State of Wisconsin for the year 1851, and of the laws passed at said session.

Condition of appropriation.

SEC. 2. No portion of the sum appropriated by the first section of this act shall be drawn from the treasury by the said C. Latham Sholes, until his contract shall have been complied with, and the laws and journals contracted for by him shall have been deposited with the Secretary of State.
