

opened at all times for the passage of boats, rafts, and other crafts free of charge and without unnecessary delay.

Rates of toll.

SEC. 3. The said grantees shall after the completion of said bridge, have power to demand and collect tolls for passing over the same, as follows: for any vehicle drawn by one horse, ten cents; for any vehicle drawn by two horses or oxen, twenty cents, for each additional horse five cents; for foot passengers three cents; for all animals in droves, three cents each: *Provided*, That hogs and sheep shall not be charged more than two cents per head.

SEC. 4. The legislature may at any time amend or repeal this act.

## Chap 142

An Act to provide for the removal of the county seat of Marquette county.

*The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

May vote for removal of county seat to Montello

SECTION 1. That at the annual town meeting to be held in the county of Marquette on the first Tuesday of April, A. D. 1852, the legal voters of said county shall be and are hereby authorized to vote for the removal of the county seat of said county, to the village of Montello in said county; and if a majority of all the votes cast on that subject at such town meeting shall be in favor of such removal of said county seat to said village of Montello, then said village of Montello shall be the permanent county seat of said county.

May vote for removal to Princeton.

SEC. 2. If a majority of all the votes cast on that subject shall not be in favor of such removal of said county seat to said village of Montello, then it shall be lawful for the legal voters of said county of Marquette to vote on the first Monday of September in the year 1852, for the removal of the county seat of said county to the village of Princeton in said county, and the votes cast on the subject of such removal of said county seat on said first Monday of September, shall be received by the inspectors of elections in the several townships of said county, at polls to be opened by them for that purpose at the places where the polls of the last preceding elections were held, and the elections mentioned in this section shall be conducted in the manner

provided by law for conducting general elections; and if a majority of all the votes cast on the subject of such removal of said county seat shall be in favor of the removal of the same to said village of Princeton, then said village of Princeton shall be the permanent county seat of said county.

SEC. 3. The votes cast on the subject of the removal of said county seat as above provided shall be by ballot, and shall be returned and canvassed in the same manner as votes cast at elections for county officers, at the town meeting above mentioned, to be holden on the first Tuesday in April, 1852; said ballots shall have written or printed on them, or partly written and partly printed, the words "For removal to Montello," or the words "Against removal to Montello;" and at the election to be holden in said county on the first Monday of September, 1852, as above provided, said ballots shall have written or printed on them, or partly written and partly printed, the words, "For removal to Princeton," or the words, "Against removal to Princeton."

Form of ballots.

SEC. 4. All persons residing on the west side of Fox river in said county of Marquette, and qualified to vote at a general election, are hereby authorized to vote on the question of removal of said county seat as above provided, at the polls that shall be held nearest to their residence, and the oath to be administered to such voters in case of challenge, shall be so varied as to agree with the provisions of this section.

Where certain electors to vote.

SEC. 5. It shall be the duty of the clerk of the board of supervisors of said county of Marquette, immediately after the canvassing of the votes for and against the removal of said county seat to said village of Montello, to publish the result of the same in some newspaper printed in said county, or in some one of the newspapers printed in Madison. And if a majority of said votes shall not have been given for the removal of said county seat to the said village of Montello, then it shall be the further duty of said clerk, immediately after the canvassing of the votes that shall be cast for or against the removal of said county seat to said village of Princeton as above provided, to publish the result of the same in some newspaper printed in said county, or in some one of the newspapers printed in Madison.

Clerk of the Supervisors to publish result.
