

**Chap 188** An Act to amend an act entitled "An Act to provide for the removal of the County Seat of Marquette County," approved March 23d, 1852.

*The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

**SECTION 1.** That at the general election in November next, the electors of the county of Marquette may vote for the removal and permanent location of the county seat of said county at Montello, and if said Montello shall receive a majority of all the votes cast at said election on that subject, then said Montello shall be the permanent county seat of said county; and the votes cast on the question of the removal and location of said county seat, shall be received, returned, and canvassed in the same manner as votes cast for county officers.

May vote for removal of county seat.

**SEC. 2.** It shall be the duty of the clerk of the board of supervisors to publish the result of the said election in the manner required by section five of the act to which this is amendatory; and the votes cast at such election shall have written or printed or partly written and partly printed upon them, the words, "For removal of county seat to Montello," or the words, "Against removal of county seat to Montello;" and all persons may vote upon such removal who reside upon the west side of Fox river in said county, and are qualified to vote at a general election.

Form of ballot. Act repealed.

**SEC. 3.** So much of the act to which this act is amendatory as conflicts, or is inconsistent with the provisions of this act, is hereby repealed: *Provided*, That the said county seat shall not have been located by previous vote at Princeton.

**SEC. 4.** This act shall take effect from and after its passage.

An Act to authorize the erection of a free bridge across the Milwaukee River.

**Chap 189**

*The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

**SECTION 1.** Lyman P. Swift, Peter Bender, and their associates, are hereby authorized to build, erect, and main-

tain a free bridge across the Milwaukee river, in the county of Milwaukee, on or near the quarter line of sections twenty nine and thirty of town eight: *Provided*, That in case the banks of the river where such bridge is authorized to be built, are not laid out as a highway, or owned by said Swift and associates or any of them, said Swift and associates or some of them shall obtain the written consent of the owner or owners of such bank or banks, not so laid out or owned, to the construction of such bridge.

SEC. 2. Said bridge shall be so constructed as not to obstruct the navigation of said river.

SECTION 1. There is hereby appropriated to Benjamin F. Moore the sum of thirty-one dollars and forty cents, in full for incidental expenses incurred by the committee appointed to examine the affairs of the state land office, to be paid out of any money in the treasury not otherwise appropriated.

An Act to appropriate to F. A. Beckel, Treasurer of Dodge County, the sum therein named.

Chap 191

*The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

SECTION 1. There is hereby appropriated to Frederick A. Beckel, Treasurer of Dodge county, out of any money in the treasury not otherwise appropriated, the sum of one
