Chap 302

The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows :

SECTION 1. There is hereby appropriated to Joseph Jones, out of any money in the state treasury not otherwise appropriated, the sum of eighteen dollars, in full for services as guard to take John C. Calvert, a state prisoner, to Waupun, in the year 1852.

An Act to amend an act entitled "An act to authorize the City of Racine to aid in the construction of certain plank roads," approved February 16th, 1852.

Chap 303

The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows :

SECTION 1. The act entitled "An act to authorize the city of Racine to aid in the construction of certain plank roads," approved February 16, 1852, is hereby so amended that said city is authorized to subscribe four thousand dollars to the capital stock of a company to be formed to construct a plank road from said city in a northern direction to the county line, or to issue its bonds therefor: *Provided*, Said proposed company is duly organized, and the sum of four thousand dollars actually and in good faith subscribed to the capital stock thereof, and properly secured. Act amended.
Proviso.

SEC. 2. The above mentioned act is also so amended that said city is authorized to subscribe six thousand dollars to the capital stock of a company now formed to construct a plank road from Racine to Raymond, or to issue its bonds therefor: *Provided*, Said company shall actually and in good faith obtain subscriptions to the amount of eight thousand dollars to the capital stock thereof, and properly secured. Further amend-
ment.
Proviso.

SEC. 3. This act shall take effect from and after its passage.

Chap 304 *The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

Act amended. SECTION 1. Section four of the act entitled "An act to incorporate Whitewater Academy," approved February 18th, A. D. 1852, is hereby so amended that the words "first Monday of March" shall be changed to "first Monday of May."

SEC. 2. This act shall take effect from and after its passage and its approval by said corporation at any legal meeting thereof.

An Act to amend the charter of the Fort Winnebago and Duck Creek Plank Road Company.

Chap 305 *The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:*

Charter amended. SECTION 1. Section number two of chapter number two hundred and fifty-eight of the session laws of 1850 entitled "An act to incorporate the Fort Winnebago and Duck Creek plank Road Company," is hereby amended so that the stockholders of said company are hereby authorized and empowered to fix the termination of said road at any point in the town of Fort Winnebago they may see fit: *Provided*, It be done by a majority of all the legal votes of
