## **Chap 461**

An Act to apprepriate to John Taylor the sum therein named.

## Chap 462

An Act to provide for the taxation of all property in this State.

The people of the State of Wisconsin, represented in Senate and Assembly do enact as follows:

Act repealed.

SECTION 1. Chapter 267 of the statutes of the state of Wisconsin in the year 1850, entitled, "An act to amend the existing laws relating to the assessment and taxation of

personal property," is hereby repealed.

Acts revived.

SEC. 2. All acts and parts of acts altering, amending, or repealing in any manner, chapter, fifteen, title five, of the revised statutes of the state of Wisconsin, entitled, "Of the assessment and collection of taxes," or of any part thereof, are hereby repealed, and all those provisions of said chapter fifteen, title five, of said revised statutes, heretofore altered, amended, or repealed by any act or acts, are hereby revived and declared to be in force.

Amount of tax secertained.

Sec. 3. The assessor in each town or ward shall proceed, at the time prescribed in section sixteen of said chapter fifteen, title five, of the revised statutes, to the proper offices, to ascertain the amount of such taxable personal property held by persons residing in his town or ward, as has been recorded in said offices.

SEC. 4. This act shall take effect from and after its pub-

lication.

An Act to provide for levying a State Tax.

Chap 463

The people of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

Section 1. There shall be levied and collected for the year 1852, in addition to the one-fifth of one mill on the dollar valuation, by law to be collected for the purpose Tax isvied. of paying the interest on the fifty thousand dollar state loan, a state tax of three mills and three tenths of one mill on the dollar valuation; such entire state tax of three and one-half mills on the dollar valuation, to be levied, collected, and paid into the state treasury as is provided by the revised statutes of this state.

SEC. 2. The supervisors of the respective counties are hereby required to levy the foregoing tax upon the taxable property in their several counties according to the laws of

the state for the assessment and collection of taxes.

Sec. 3. The secretary of state is hereby required, immediately after the passage of this act, to cause the same Act to be sent to to be published by the state printer in a newspaper printed views. at the seat of government, and transmit to each clerk of the board of supervisors of the several counties of this state, a copy of the newspaper containing this act.
