The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

§ 1. The name of Mary Conger, infant daughter of Name and heter-Anna Conger, is hereby chauged to Mary Anne Tor chip of Mary rey, by which name she shall be hereafter known and od recognized.

§ 2. The said Mary Anne Torrey shall be esteemed and taken to be the heir at-law of Wilson Torrey and Urania Torrey his wife, of Fox Lake, in the county of Dodge, and the mutual obligations of parent and child shall exist and pertain as fully between the said Wilson Torrey and Uriana Torrey, and the said Mary Anne Torrey, as in the case of mutual parentage.

§ 3. This act shall take effect from and after its

passage.

AN ACT to amend an act entitled "An Act to provide for more fully carrying into effect the general Banking Law of this State." Approved March 18, 1856.

§ 1. An act entitled "An act to provide for more salary of Clerk fully carrying into effect the General Banking Law of this State," approved March 18, 1856, is hereby amended by striking out the words "six hundred" where they occur in the first and second sections of said act,

AN ACT to appropriate to Wolfgang Rublee and others, the sum therein named.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Money [paid : for school lands refunded.

§ 1. There is hereby appropriated to the several persons hereinatter mentioned, out of any money in the State Treasury not otherwise appropriated, the several sums of money hereinafter set forth in full, of purchase money, interest and damages sustained by them in consequence of the failure of title of several tracts of land purchased by them of the State to which the State has no title, viz.: To Wolfgang Rublee, for purchase money, interest and damages on the north-west quarter of the south east quarter of section seven (7), town nine, north of range twenty-two east, the sum of one hundred and sixty-one and 67-100 dollars; to Philip Wirgand, for the purchase money, interest and damages on the north east quarter of the south east quarter of section seven, town and range aforesaid, the sum of two hundred and eighty-one and 86-100 dollars; to John Barth, for purchase money, interest and damages on the south west quarter of the south-east quarter of same section, town and range, the sum of one hundred and ninety-eight and 65-100 dollars; to Helena Miesegardes, for purchase money, interest and damages on south-east quarter of South east quarter of said section, town and range, the sum of one hundred and ninety-eight and 65-100 dollars; to Karl Kichhafer for purchase money, interest
