the old county of Washington, and it shall be ascertained that one of the said counties has paid its legal and equal share of such indebtedness, then the said county which shall not have paid its share of such indebtedness shall be liable to discharge the remainder of the said indebtedness; and in case it shall appear at such settlement that one of said counties has paid more than its legal share of indebtedness, as provided in the act to which this act is amendatory, then the county which has not paid its legal share of indebtedness, as required in the act above referred to, shall refund to the other county, such sum or sums of money which has been overpaid by such county, on said indebtedness.

SEC. 2. This act shall take effect and be in force from and after its passage.

An Aor to amend chapter forty-eight of the Revised Statutes, entitled "Of Cemetry Associations."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The organization of no cemetery associaaccount of fail- tion organized under chapter forty-eight of the Revised Statutes, shall be void in consequence of any failure to obtain and put on record a deed of the property of such association, or which shall have failed to file in the office of the Register of Deeds of the proper county the certificate of organization within the time limited by said act.

SEC. 2. No cemetery association organized under in case of fail- said act shall be deemed forfeited in consequence of any failure to hold the annual meeting for the election of officers at the time specified by said act, unless three consecutive years shall, have passed without holding such annual meeting for the election of officers: Provided, however, That the organization of no cemetery

association shall be deemed completed and perfected until the certificate of organization, and the deed of the land held by such cemetery association shall have been recorded in the office of the Register of Deeds of the proper county, nor until the map specified in section seven of said act shall also have been filed in said Register's office.

All deeds or transfers of lots, executed by All deeds, dec. any cemetery association to individuals, after the same after being reshall have been recorded, shall be filed in the office of filed with the town clerk, or with the clerk of the city within town clerk. which the said cemetery shall be situated.

SEC. 4. This act shall take effect and be in force from and after its passage and publication.

That chapter seventy-seven of the general Repealed and laws of eighteen hundred and fifty-three, entitled "An revived. act to amend chapter one hundred and thirty-six of chapter ten of the Revised Statutes," approved April second, eighteen hundred and fifty-three, be and the same is hereby repealed, and said section one hundred and thirty-six is hereby revived and restored to full force and effect.

SEC. 2. This act shall take effect and be in force from and after its passage.
