AN ACT to remit to the county of Dodge the penalty charged for delinquency in the payment of state tax of 1857.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The sum of four hundred and twenty Remission of dollars and fifty-seven cents, the amount of the twenty-tax. five per cent penalty charged to the county of Dodge for the delinquency in the payment of the state tax of the year 1857, on the first day of October, 1858, by the secretary of state in accordance with the provisions of sections one and two of chapter 152 of the general laws of 1858, be and the same is hereby remitted to said county, and the secretary of state and state treasurer are hereby directed to make the neccessary entries to the credit of said county.

CHAPTER 85.

AN ACT to provide for the payment of certain accounts for newspapers.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The secretary of state is hereby author-Accounts to ized to audit the accounts of the several newspaper pub-be audited. lishers for papers furnished to the legislature during the present session, and to settle such accounts, allowing said publishers at the rates at which said newspapers respectively are furnished to subscribers at the places of publication.

SEC. 2. Such accounts shall be verified by the oath To be verified of the persons furnishing the newspapers, that the papers were ordered either by the chief clerk or the person to whom they were sent and furnished, and that the said accounts are just and true as to number and price, as provided in the preceding section of this act.

SEC. 3. The secretary of state is hereby authorized Appropriation

to draw warrants on the state treasurer in favor of the persons, respectively, to whom such accounts are found due for newspapers; and there is hereby appropriated out of any money in the state treasury not otherwise appropriated, a sum sufficient to pay the same.

SEC. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 86.

AN ACT to amend chapter ninety-four of the revised statutes, entitled "of the sale of lands for the payment of debts, by executors, administrators, and guardians."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

How amended SECTION 1. Section twelve, of chapter ninety-four of the revised statutes, entitled "of the sale of lands for the payment of debts by executors, administrators and guardians," is hereby amended by striking out of subdivision number two of said section twelve, all of the following words—viz: "And that they are not secured by judgment or mortgage upon, or expressly charged on the real estate of the deceased; or if such debts be secured by mortgage or charge on a portion of such estate, then that the remedies of the creditor by virtue of such mortgage or charge have been exhausted."

Take effect.
