AN ACT to amend chapter 132, of the Private and Local Laws of 1859, entitled "An act to amend an act, entitled, 'An act to incorporate the city of Beaver Dam.'"

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section one, of chapter one hundred and Amendssec. 1 thirty two, of the Private and Local Laws of 1859, is of act. amended, so as to read as follows: "The term of office of the city and ward officers of the city of Beaver Dam shall commence on the first Tuesday of May next after their election."

SEC. 2. Section two, of the act to which this act is Amends sec2. amendatory, is hereby amended, by striking out the words "second Tuesday of April," where they occur in said section, and inserting therefor the words "first Tuesday of May next:" *Provided*, that all the officers of said Proviso. city, now in office, shall hold their respective offices until their successors shall be elected, appointed and qualified, as required by law.

SEC. 3. All acts or parts of acts, and laws contraven-Repeal. ing or inconsistent with the provisions of this act, are hereby repealed, so far as the same apply to or affect any of the provisions of this act.

SEC. 4. This act shall take effect and be in force from its passage.

CHAPTER 79.

AN ACT to postpone the sale of land for unpaid taxes in the county of Richland.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The treasurer of the county of Richland Treasurer auis hereby authorized to postpone the sale of lands, re-thorized to turned to him for the non-payment of taxes, for the year postpone sale. 1859, until the second Tuesday of May next, when such sale shall commence, and be continued from day to day, and shall be subject to the same rules and regulations, and governed by the same laws, that are now in force relative to the sale of land for unpaid taxes.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 80.

AN ACT to prescribe the daties of the Secretary of State, in certain cases, and to repeal chapter 155, of the General Laws of 1858, entitled "An act providing for the appointment of a Comptroller, and prescribing his duties."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. All claims and and accounts against the of Becretary state to audit State, authorized by law to be audited, shall be audited accounts. by the Secretary of State, as required by law. The order of the Secretary of State, auditing any claim or account, shall be endorsed on or annexed to such claim or account, and shall state particularly the acts, or parts of acts, which authorize such elaim or account, and confer the power to audit the same, and, together with such claim, and all evidence relating thereto, shall be delivered to the Treasurer, and shall thereafter remain on file in his office, until the same shall be paid, when such account and evidence shall be returned to the office of the Secretary of State, and be filed and kept in the said office.

SEC. 2. Chapter one hundred and fifty-five, of the General Laws of 1858, entitled "An act providing for the appointment of a Comptroller, and prescribing his duties," is hereby repealed.

SEC. 3. This act shall take effect and be in force from and after its passage.
