CHAPTER 10.

AN ACT to amend Chapter 236 of the General Laws of 1860, entitled "An act to organize the county of Door for judicial purposes."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section two (2) of chapter 286 of the general laws of 1860, is hereby amended by striking out all of said section after the word "circuit," in the second line, and inserting in lieu thereof the following: And there shall be held two terms of the circuit court, in said county, at the county seat thereof, in each year: one term on the third Monday of February, and one term on the second Monday of July.

SECTION 2. This act shall take effect and be in force from and after its passage.

AN ACT to amend Chapter 874 of the General Laws of 1860, entitled "An act to authorize the Governor of the State of Wisconsin to seize certain land on Green Island, for the use of the State."

The People of the State of Wisconein, represented in Senate and Assembly, do enact as follows:

Stotion 1 amonded. SECTION 1. That section one of said act be and is hereby amended by striking out the words "south west,"

Two terms of sourt provided and inserting in lieu thereof the words "south east," so that it shall read as follows : "The governor of the state of Wisconsin is hereby authorized and empowered to seize and take possession of, for the use of the state, any land not exceeding two acres, situate on the southeast corner of Green Island, in Green Bay, in this state, for the purpose of ceding jurisdiction thereof to the United States, for the erection and maintenance of a lighthouse thereon."

SECTION 2. That the tract of land on Green Island, Land adopted for which was selected and surveyed on the south-east end house. of said island, on the 12th day of September, 1860, by the commissioners appointed in pursuance of said act, be and is hereby adopted as the site for a lighthouse on said island; and the said commissioners shall proceed to ascertain and fix the value thereof, and in all Value to be fixed respects to carry out the provisions of said act, to which this act is amendatory.

This act shall take effect and be in force SECTION 3. from and after its passage.

CHAPTER 12.

AN ACT to extend the time of selling lands for taxes in Douglas County.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The sale of lands in the county of Doug- Sale of lands postponed. las for the delinquent taxes for the years 1859 and 1860, is hereby postponed until the sale of lands in said county for the delinquent taxes for the year 1861, at which time the county treasurer of said county shall include the delinquent lists for the years 1859, 1860 and 1861, in one advertisement and one sale.

"SECTION 2. This act shall be immediately published. and shall take effect and be in force from and after its passage and publication.'
