CHAPTER 149.

AN ACT to authorize the Common Council of the city of La Crosse to grant Ferry Licenses within the corporate limits of the same.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Powers conferred

SECTION 1. The common council of the city of La Crosse is hereby authorized and empowered to grant ferry licenses within the corporate limits of the same, and to have and exercise in that respect all the powers and privileges now used and exercised by the several counties of this state under general laws.

Section 2. This act shall take effect and be in force

from and after its passage and publication.

CHAPTER 150.

[Published April 3, 1861.]

AN ACT requiring the State Treasurer to make out and forward to the County Treasurers certain lists of School, University and Swamp Lands.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Lists to be made out, and what to contain.

Section 1. The state treasurer shall forward quarterly to the treasurers in each county in this state, a list of all school, university and swamp lands, and lands mortgaged to the state, located in such counties respectively, on which the taxes and interest on the taxes shall have been collected and paid into the state treasury, as provided in section five of chapter three hundred and six of the general laws of 1860. Said lists shall state the amount of taxes and interest paid on each separate tract of land contained therein, which said amount of taxes and interest thereon, when paid into the state treasury, shall be placed to the credit of the proper county.

SECTION 2. Said list shall designate separately each Lots to be designated. lot or tract of land on which such tax and interest has been collected, specifying the section, township and

range in which the same is embraced.

SECTION 3. Immediately upon the receipt of said Duty of treasurer on receipt of list by any county treasurer, he shall ascertain the ag-list. gregate amount of such tax and interest collected as aforesaid on such lands in each of the organized towns in his county, and shall credit to the proper towns respectively the full amount of the taxes and interest collected as aforesaid on lands embraced within such towns: provided, the amount of said taxes and interest shall Provise. have been paid over to such county treasurer, or shall have been credited to such county by the state treasurer, as provided in said section five of chapter three hundred and six of the act aforesaid.

Section 4. This act shall be in force from and after its passage.

CHAPTER 151.

[Published April 5, 1861.]

AN ACT to authorize the city of Green Bay to issue the bonds of , said city for the purpose of taking up and canceling the outstanding bonds of said city heretofore issued.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. It shall be lawful for the city of Green May issue bonds Bay, and said city is hereby authorized in the corpo-pose, &c. rate capacity of said city, to issue bonds to the holders of the bonds now outstanding against said city, payable in one, two, three and consecutive years, not exceeding ten years from the date of such bonds issued under this act, together with interest coupons attached thereto, bearing such rate of interest as the city council may direct, and payable as said council may direct, not exceeding eight per cent. per annum, and in such amount and in such sums, may also direct: provided, that no bonds shall be issued under and by virtue of this act for any other purpose than taking up and can-
