CHAPTER 243.

[Published April 19, 1861.]

AN ACT in relation to negotiable paper maturing upon Sunday, or upon a legal holiday.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

To be paid on preceding day.

SECTION 1. Whenever the fourth day of July, the twenty-fifth day of December, the first day of January, and the twenty-second day of February, shall fall upon Sunday, the following Monday shall be a legal holiday; and all notes, drafts, bills of exchange, or other paper maturing on said Sundays and Mondays, shall be due and payable on the secular day next preceding. All such notes, drafts, bills of exchange, or other paper maturing on Sunday or upon any legal holiday, shall be due and payable upon the next preceding secular day.

SECTION 2. All acts or parts of acts inconsistent with the provisions of this act, are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage.

CHAPTER 244.

[Published April 26, 1861.]

AN ACT to amend Chapter 150 of the General Laws of 1860, entitled "An act to provide for the disposal and expenditure of the Drainage Fund moneys in Shawanaw county.

The People of the State of Wisconsin, represented in Senats and Assembly, do enact as follows:

When fund to be paid.

^b SECTION 1. That portion of the interest of the drainage fund which is due the county of Shawanaw for the year 1861, shall be paid over to the county treasury of said county at the same time with the money due to said county from the school fund for that year, and shall be paid out by said county treasurer

only on the order of the commissioners hereinafter mentioned for said county, as hereinafter directed.

SECTION 2. The moneys mentioned in section one To be expended of this act shall be expended on such road or roads as the county board of supervisors of said county shall direct.

Horace Wescott, A. G. Rockwell and Commissioners. SECTION 3. Herman Naber, are hereby appointed commissioners for said county, and said Horace Wescott shall be acting commissioner, and shall have the immediate superintendence of the work done on said road or roads, and shall receive for his services the sum of one dollar and Salary. fifty cents per day for every day actually spent by him in the superintendence of said work : provided, that in Provise. the case of the incapacity or refusal of said Horace Wescott to discharge the duties of acting commissioner as aforesaid, either of the other two commissioners may discharge the duties and receive the pay of acting commissioner, until the register of deeds, county treasurer and clerk of the board of supervisors of said county, by warrant under their hands, appoint a substitute for said Horace Wescott.

SECTION 4. Said commissioners shall have control Duties of comand superintendence of the expenditure of the moneys so paid to said county. They may draw orders on the county treasurer of said county, payable from the drainage fund, and employ such overseers, laborers or engineers, or let such contracts, as they may deem necessary. They shall keep a record of their doings, and vouchers for all moneys drawn out by them, and shall make a full report of their doings and expenditures to the county board of supervisors of said county, at the November session of 1861.

SECTION 5. Sections 5 and 6 of chapter 150 of the Repeal. laws of 1860, and all other acts and parts of acts, so far as they contravene the provisions of this act, are hereby repealed.
