hundred and fifty-nine, and shall be held and used by Held and used. the several districts receiving the same as provided in section third [three] of said chapter one hundred and thirty-eight aforesaid.

SECTION 3. There is hereby appropriated out of the Appropriation. income of the school fund a sum of money sufficient to pay for the dictionaries provided for in this act, and the state superintendent of public instruction shall certify to the state treasurer the amount of such expenditure.

SECTION 4. The state superintendent of public in-Loss to be supstruction is hereby authorized to furnish any school district heretofore supplied, but now destitute through loss by fire or theft, with a copy of Webster's unabridged dictionary upon a receipt from the state treasurer, showing that the cost of such dictionary to the state has been paid into the state treasury: *provided*, that Proviso. the affidavit of the town superintendent of such loss, shall first be filed with the superintendent of public instruction.

SECTION 5. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 42.

AN ACT to extend the time for the collection of taxes in the town of Shullsburg, in the County of La Fayette.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows :

SECTION 1. The time for the collection of taxes in Time extended. the town of Shullsburg, in the county of La Fayette, in this state, is hereby extended to the first day of June, A. D. 1861: provided, that nothing in this act shall be so construed as to prevent the town treasurer of said town from collecting and paying over to the county treasurer of said county, the state tax assessed in said state tax. town; and provided, that the time for the payment of state tax is not extended or in any way affected by this act. Authority of town treasurer.

SECTION 2. The town treasurer of said town shall have the same power and authority to proceed in the collection of the taxes mentioned in the assessment roll and warrant in said town, after as before such extension of the time for the collection thereof; and said town treasurer may make his return to the county treasurer of said county at any time beforé the said first day of June, A. D. 1861, anything in such warrant to the contrary notwithstanding.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 43.

AN ACT to extend the time for [the] collection of taxes in the town of Pulaski, in Iowa County.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Time extended.

SECTION 1. The time for collecting of taxes (except state taxes) in the town of Pulaski, in Iowa county, in this state, is hereby extended to the first day of June, A. D. 1861.

Authority of SECTION 2. The town treasurer of said town shall have the same power and authority to proceed in the collection of the taxes in said town after as before such extension.

May make return SECTION 3. The said town treasurer may make his return to the county treasurer of said county at any time before the first day of June, A. D. 1861, anything in such warrant to the contrary notwithstanding.

SECTION 4. This act shall take effect and be in force from and after its passage and publication.
