CHAPTER 75.

AN ACT to repeal Section 1 of Chapter 314 of the General Laws of 1860, entitled "An act for the preservation of fish in the counties of Manitowoc and Kewaunee."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Repeal.

SECTION 1. Section 1 of chapter 314 of the general laws of 1860, entitled "An act for the preservation of fish in the counties of Manitowoc and Kewaunee," is hereby repealed.

SECTION 2. This act shall take effect and be in force on and after its passage.

CHAPTER 76.

AN ACT to amend Section 27 of Chapter 535 of the Local Laws of 1856, entitled "An act to incorporate the borough of Fort Howard."

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Limit of tax.

SECTION 1. That the proviso to section 27 of chapter 535, of the local laws of 1856, be so amended as

read as follows: "Said tax shall in no one year exceed five mills on the dollar valuation."

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 77.

[Published March 19, 1861.]

AN ACT to authorize towns to assess and collect additional School Moneys in certain cases, and the Town Clerk to certify thereto.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Those towns that have not assessed for the year 1860, by order of the county board of supervisors, a sum of money equal to one-half the amount received from the school fund, are hereby authorized to supply such deficiency by an immediate assessment upon the taxable property of said town, of such sums as shall be necessary; the same to be estimated and directed by the board of supervisors of the respective towns, to be levied and collected in the same manner as other taxes; and such levy and collection to be certified to by the town clerk to the state superintendent, previous to the apportionment of the income of the school fund in the present year.

What towns may assess, &c.

SECTION 2. The state superintendent is hereby instructed to notify any delinquent towns, as shall appear from returns in his office, of the passage and provisions of this act, and he is authorized to apportion to such towns as comply with the provisions of this act, the sums of money they may thereby be entitled to.

Delinquent towns to be notified.

SECTION 3. This act shall take effect and be in force on and after its passage.
