AN ACT to amend an act entitled "an act to consolidate and amend an act to incorporate the city of Milwaukee, and the several acts amendatory thereof," approved February 20th, 1852.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. Section one of chapter two of an act en-when annual titled "an act to consolidate and amend the act to in-held. corporate the city of Milwaukee, and the several acts amendatory thereof," approved February 20th, 1852, is hereby amended by striking out the word "March" where it occurs in the said section, and inserting in lieu thereof the word "April;" and section seventeen (17) office to comoff the said chapter of the said act is hereby amended mence. by striking out the word "March" where it occurs in said last mentioned section, and inserting in lieu thereof the word "April;" and all the elective officers of from of present the said city of Milwaukee, and the several wards tended. thereof, now in office, shall hold their respective offices until their successors shall be elected and qualified, as required by the laws relating to said city.

CHAPTER 43.

AN ACT to extend the time for the collecting of taxes in the city of Racine, in the county of Racine.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The time for collecting the state and Extended to (and) county taxes in the city of Racine, in the county of Racine, is hereby extended until the first Tuesday of April next; and the treasurer of said city shall have the same right to levy on property and sell the same within said time so extended, as is now allowed by law for such purposes.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 44.

[Published February 28, 1862.]

AN ACT to extend the time for the collection of taxes in the county of Eau Claire.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

lixtended to March 81. SECTION 1. The time for the collection of taxes in the county of Eau Claire, is hereby extended till the thirty-first day of March, 1862: provided, that this act shall not be so construed as to extend the time for the payment of state taxes.

SECTION 2. The treasurers of the several towns in said county, shall have the same power and authority to collect the taxes contained in the tax rolls of said towns, after as before such extension of time for the collection of said taxes; and the return [returns] of the town treasurers to the county treasurer within the time herein limited for the collection of taxes, shall be as valid as if made pursuant to the direction of the original warrant [warrants.]

SECTION 3. This act shall take effect from and after its passage.
