AN ACT to legalize the sale of the Beloit and Madison railroad, and to reorganize the Beloit and Madison R. R. Co.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Acts legalized.

SECTION 1. That all of the proceedings for the foreclosure and sale of said Beloit and Madison railroad, its franchises, privileges and property, be, and the same is [are] hereby legalized and fully confirmed, and that all of the proceedings of John B. Turner and William H. Brown, and their associates, and their acts and doings in reorganizing said railroad company, are also hereby legalized; and it is further enacted, that said John B. Turner and William H. Brown, and their associates, successors and assigns, shall be a body politic and corporate, under the name and style of the Beloit and Madison railroad company, and shall possess all the powers, privileges and authority possessed by the said Beloit and Madison railroad company before the same was foreclosed, under and by virtue of its charter and of any law of this state.

SECTION 2. It is also further enacted, that said cor- Acts legalised, posation, so hereby legalized, may, by vote of the directons. assume any liabilities secured by any previous mortgage; and any mortgage or mortgages which it may have made to secure any existing liabilities, or to obtain money to build and complete, use and operate said railroad, is hereby legalized; and all subscriptions made to the purchasers and their associates, or to said corporation while the same was being reorganized, and for and in behalf of said Beloit and Madison railroad, or to the capital stock of said company, to aid in the completion of said road or otherwise, and before the passage of this act, are hereby legalized and made valid : provided, that Liability of comthe said Beloit and Madison railroad company, and all pany. property belonging to said company, shall be liable and holden for the payment of a certain judgment in favor of David Merrill, rendered on the 12th day of January, A. D. 1858, and against the original Beloit and Madison railroad company.
