CHAPTER 51.

[Published March 17, 1863.]

AN ACT to provide for the purchase of certain copies of Webster's dictionary, for the supply of deficient school districts of the state.

The people of the state of Wisconsin, represented in scante and assembly, do enact as follows :

SECTION 1. The state superintendent of public in-state superinten struction, with the consent and approval of the govern- dent to purchase. or, is hereby authorized to purchase, on behalf of the state, one hundred copies of Webster's unabridged dictionary of the English language : provided, that the Price. cost shall not exceed four dollars and fifty cents per copy, to supply the deficient school districts of the state.

SECTION 2. Such dictionaries, when purchased, shall How to be distributed. be distributed by the state superintendent, on the receipt of the affidavit, in due form, (which shall be kept in his office,) of any town or district clerk, or city superintendent of schools, that such town, city or district, or any public school or department in the public schools thereof, has not yet been supplied by the state with a copy of the said dictionary, sending one dictionary for each public school or department thereof, taught therein.

SECTION 3. Such dictionaries, when received by the shall being to several districts in this state, shall be considered as belibrary, &c. longing to the library of the district, and shall be subject to the same laws and regulations as other library books; but during the time a school shall be taught therein, it shall be and remain in the school room during the hours of school, for the exclusive use of the scholars and teachers of such schools, and under the control of the teacher or principal, who shall be responsible to the district for its loss, or for any unnecessary damage it may receive, the same as any other book of the district library.

SECTION 4. There is hereby appropriated out of the Appropriation. income of the school fund, a sum of money sufficient to pay for the dictionaries provided for in this act, and the

state superintendent of public instruction shall certify to the state treasurer the amount of such expenditure. SECTION 5. This act shall take effect and be in force from and after its passage and publication. Approved March 13, 1863.

CHAPTER 52.

[Published March 17, 1863.]

AN ACT to change the time of holding the general terms of the circuit court in the sixth judicial circuit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. That hereafter, the general terms of the General terms. circuit court in and for the counties composing the sixth judicial circuit in this state, shall be held as follows, to wit: In the county of Clark, on the first Monday of Clark county. March, and the first Monday of September, in each year; in the county of Jackson, on the second Monday Jackson. of March. and the second Monday of September, in each year; in the county of Monroe, on the third Mon-Monroe. day of March, and the third Monday of September, in each year; in the county of La Crosse, on the fourth I.a. Crosse. Monday of March, and the fourth Monday of September, in each year; in the county of Vernon, on the Vernos. fourth Monday of April, and the second Monday of October, in each year; in the county of Richland, on the . Richland. third Monday of April, and the third Monday of October, in each year; in the county of Crawford, on the Grawford. fourth Monday of May, and the fourth Monday of October, in each year; in the county of Trempealeau, on Trempcaleau. first Monday of May, and the first Monday of November, in each year; in the county of Buffalo, on the Buffalo. second Monday of May, and the second Monday of November, in each year.
