

CHAPTER 60.

[Published March 20, 1863.]

AN ACT to amend chapter 248 of the private and local laws of 1853, entitled "an act to incorporate the Fond du Lac and Mississippi railroad company."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Directors may be chosen after 100 shares shall have been subscribed.

SECTION 1. Section three (3) of chapter two hundred and forty-eight (248) of the private and local laws of 1853, entitled "an act to incorporate the Fond du Lac and Mississippi railroad company," is hereby amended, by striking out of the second line of said section the word "three," and inserting in place thereof the word "one."

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 80.

[Published March 25, 1863.]

AN ACT to amend the articles of association of the Milwaukee and Prairie du Chien railway company.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Annual meetings in June.

SECTION 1. The annual meetings of the stockholders and election of directors of the Milwaukee and Prairie du Chien railway company, may, with the approval of the stockholders, be hereafter held in the month of June, of each year, at such time and place within the state of Wisconsin, as the directors may specify.

Annual report to be sent first Feb.

SECTION 2. The annual report of the company's business, acts and doings, shall hereafter be sent to each stockholder, as registered on the company's books, on the first day of February of each year succeeding the year for which the report is made.

SECTION 3. The approval by the stockholders, or a majority of them, at any general or special meeting, of these alterations of their articles of association, shall be certified to by the chairman and secretary of such meeting, and such certificate shall be filed with the secretary of state of this state, and thereupon so much of the articles of association of the Milwaukee and Prairie du Chien railway company as is not in accordance herewith, shall be repealed and stand null and void. Approval of these alterations.

SECTION 4. This act shall be in force and take effect from and after its passage.

CHAPTER 84.

[Published March 26, 1863.]

AN ACT to extend the time for the expiration of the charter of the Wisconsin Central railroad company, as limited by the act of incorporation, approved March 4, 1853.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. All the rights, privileges, franchises and immunities granted to the Wisconsin Central railroad company, approved March 4, 1853, are hereby extended to said company for and during the term of five years. Extended for five years.
 years from and after the third day of March, 1863: *provided*, that the said railroad shall be completed from the state line to the village of Jefferson, by the first day of January, one thousand eight hundred and sixty-five; *and provided, further*, that nothing in this act shall in any manner affect any town bonds issued in aid of the construction of said road, or deprive the towns issuing the same of any defense which might have been interposed in any suit upon said bonds, if this act had not been passed. Proviso.
Not to affect town bonds, &c.

SECTION 2. This act shall take effect from and after its passage.
