SECTION 2. The orders so issued shall be accepted by the treasurer of said town in payment of the tax Dety ettrasurer levied for the creation of said bounty fund; and at the time of the receipt by him of any of the orders so issued, he shall indorse upon the order or orders so received, the date of reception and the amount for which any such order was so received by him, and the interest shall cease upon all orders from the date of their respective reception by said treasurer.

Orders only payable from bounty fund.

Section 3. The treasurer of the town of Taycheedah aforesaid, shall pay all orders so drawn from the fund for such purposes provided, and from no other.

## CHAPTER 187.

[Published March 22, 1864.]

AN ACT to amend section 5 of chapter ten of the revised statutes, entitled "of state officers."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Salary of lieutenant governor, while acting COVOLDOL.

SECTION 1. Section five of chapter ten of the revised statutes is hereby amended, so as to read as follows: "Whenever, from any cause, the powers and duties of the office of governor shall devolve upon the lieutenant governor, he shall receive [as] compensation for such services, the sum of five dollars per day for the time actually employed, to be audited by the secretary of state, and drawn from the treasury upon his warrant; and a sum sufficient to pay such compensation is hereby appropriated out of any money in the treasury not otherwise appropriated."

This act shall take effect and be in SECTION 2. force from and after its passage.

## CHAPTER 138.

[Published March 21, 1864.]

AN ACT to change the name of the village of Stanton, in the county of Portage.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The name of the village of Stanton, in Name changed the county of Portage, is hereby changed to Plover, and it shall hereafter be known in law and otherwise by that name; and the inhabitants of the district of country described in section one of chapter two hundred and seventy-eight of the private and local laws of 1857, entitled "an act to incorporate the village of Algernon," and in section one of chapter two hundred and three of the private and local laws of 1858, entitled "an act to amend an act entitled 'an act to incorporate the village of Algernon," shall hereafter be known by the name, style and title of the "president and trustees of the village of Plover."

Section 2. This act shall take effect and be in force from and after its passage.
