

Rivers for the purpose of building, repairing and maintaining bridges in said town and village; and all taxes voted for repairing, building or maintaining bridges as aforesaid, shall be collected in the same manner that other town taxes are collected.

SECTION 3. This act shall take effect and be in force from and after its passage.

CHAPTER 147.

AN ACT to amend chapter 347 of the private and local [general] laws of 1863, entitled "an act granting Frank Ives the right to establish and maintain a ferry across the Mississippi river."

CHAPTER 148.

[Published March 22, 1864.]

AN ACT to provide for laying out a state road from Platteville, in Grant county, to Calamine, in La Fayette county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Commissioners. SECTION 1. William Jeffrey and John Neff, of La Fayette county, and Farnum Johnson, of Grant county, are hereby appointed commissioners to lay out and establish a state road from Platteville, in Grant county, to Calamine, in La Fayette county.

Their compensation.

SECTION 2. The said commissioners shall receive such compensation for the time and services actually spent in laying out said road as may be allowed by the county boards of supervisors of the counties through which said road shall be laid, and no part of the expense thereof shall be paid by the state.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 149.

[Published March 21, 1864.]

AN ACT to extend the time for collection of the tax levied to pay bounties to volunteers, in the town of Watertown, in the county of Jefferson.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. The time for collecting the special tax to be paid as bounties to volunteers, in the town of Watertown, in the county of Jefferson, is hereby extended to the first day of April, A. D. 1864, and the tax warrant now in the hands of the town treasurer of said town, is hereby extended and continued in full force in all its provisions, till the said first day of April, 1864. If such town treasurer shall be unable to collect any portion of the taxes entered upon his tax list, he shall make return of such delinquent taxes and of the land on which the same were levied, on or before the said first day of April, 1864, to the county treasurer of said county of Jefferson. Such delinquent return shall be in the form and shall be verified in the manner prescribed by law for the return of other delinquent taxes; and the said county treasurer shall thereupon proceed therewith in the manner provided by sections seven and eight of chapter thirty-nine of the general laws of 1864.

Time extended to April 1.

Return of delinquent taxes, and collection of same.

SECTION 2. This act shall take effect and be in force from and after its passage.
