falo and Vernon, shall be held as follows: In the county of La Crosse, on the first Monday of April and the fourth Monday of September, in each year; in the county of Buffalo, on the second Monday of May and the second Monday of October, in each year; in the county of Vernon, on the fourth Monday of April and the second Monday of November, in each year.

SECTION 2. All writs, process, services, continuances, recognizances and proceedings heretofore issued, made, taken or entered into, or which may be issued, made, entered into or commenced in or from said courts, or either of them, and all proceedings pending therein or returnable thereto, whether by recognizance or otherwise, shall be held and taken as returnable at the times mentioned in this act for holding the said courts, respectively, in the said counties of La Crosse, Buffalo and Vernon.

Repeal.

SECTION 8. All acts and parts of acts, in so far as they contravene and are inconsistent with the provisions of this act, are hereby repealed.

SECTION 4. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 32.

[Published February 18, 1864.]

AN ACT relating to special terms of the circuit court in the sixth . judicial circuit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Special terms.

SECTION 1. There shall be held in the county of La Crosse, in the sixth judicial circuit, on the second Tuesday of July, in each and every year hereafter, and in the county of Monroe, in said circuit, on the first Tuesday of January, in each and every year hereafter, by the judge of the circuit court of said sixth circuit, a special term of said court for the transaction of any and all business from any county in said circuit that may be done at a regular term of said court, except the trial of issues of fact by a jury.

SECTION 2. No notice of the holding of said special required. terms shall be required other than the passage and publication of this act.

SECTION 3. Section 2 of chapter 868 of the general Repeal.

laws of 1862, is hereby repealed.

SECTION 4. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 33.

[Published February 15, 1864.]

AN ACT to authorize the town of Milford, in Jefferson county, to levy and collect a special tax to pay bounties to volunteers, and to define certain boundaries of said town.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The town of Milford, in the county of tax authorized and empowered to levy and collect a tax for the purpose of paying bounties to volunteers: provided, the amount of such tax shall have been first specified by vote of a special town meeting held pursuant to law in said town for that purpose.

SECTION 2. Sections one, two, three, ten, eleven, potached twelve, thirteen, fourteen and fifteen, of township number eight, north of range fourteen east, having been by chapter one hundred and seventy-one of the genereral laws of 1863, detached from said town, shall not be held to constitute a part of said town of Milford for any purpose whatever.

SECTION 3. This act shall take effect and be in force

from and after its passage.
