

twenty-five cents for preparing and perfecting all the necessary papers for and obtaining such aid for the person entitled thereto, shall be guilty of a misdemeanor, and upon conviction thereof shall be fined a sum not exceeding one hundred dollars, or by imprisonment in the county jail not exceeding six months, or by both such fine and imprisonment; and justices of the peace shall have concurrent jurisdiction with the circuit courts of this state, of offences mentioned in this section.

Repeal.

SECTION 4. All acts and parts of acts inconsistent with the provisions of this act, are hereby repealed.

SECTION 5. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 417.

[Published May 27, 1864.]

AN ACT to authorize and empower Levi D. Therp to build and maintain a dock and pier extending into Green Bay.

## CHAPTER 418.

[Published May 27, 1865.]

AN ACT to authorize the board of supervisors of the town of Beloit to issue new bonds for the purposes mentioned.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Bonds to amount of \$10,000 may be issued in settlement of bridge bonds.

SECTION 1. The board of supervisors of the town of Beloit, in Rock county, are hereby authorized to issue new bonds of such town, not to exceed the sum of ten thousand dollars, for the purpose of satisfying or set-

ting certain bridge bonds issued by the supervisors of said town, under chapter 329 of the laws of 1855.

SECTION 2. Said supervisors of said town are hereby authorized to issue said bonds of such denomination as they may deem proper, bearing interest not to exceed seven per cent., and payable at such time and place as they may deem advisable, not exceeding twenty years from the date of such bonds.

## CHAPTER 419.

[Published May 27, 1865.]

AN ACT ratifying the organization of a corporation therein named.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. The organization of the Milwaukee and St. Paul railway company, as provided by its articles of association, filed with the secretary of state on the fifth day of May, 1863, is hereby ratified and confirmed, and said company is hereby declared to be a corporation with all the rights, powers, privileges and franchises which were of the Milwaukee and Western railroad company, Milwaukee and Horicon railroad company, and of all that part of the La Crosse and Milwaukee railroad company pertaining to its road lying west of Portage city.
