## CHAPTER 499.

[Published May 31, 1865.]

AN ACT to legalize a public highway in the town of Beloit, in the county of Rock.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :*

SECTION 1. The acts of the supervisors of the town of Beloit, Rock county, on the 30th day of May, A. D. 1854, in laying out a highway in said town, described as follows: Commencing at a point on the Beloit and Janesville road, on the east side of Rock river, where the quarter line of section twenty-three (23) crosses said road, thence running east on said quarter line to the quarter stake or post between sections twenty-three (23) and twenty-four (24,) thence east on the quarter line through section twenty-four (24) to the town line road leading from Beloit to Janesville, are hereby legalized and declared to be valid, and the said highway is hereby declared to be a legal highway.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 500.

[Published June 2, 1865.]

AN ACT to appropriate to the town of Stockbridge certain land for school purposes.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Appropriation of lot No. 383.

SECTION 1. There is hereby appropriated to the town of Stockbridge, Calumet county, to aid in the erection of school houses in the various school districts in said town, lot number three hundred and eighty-three, in said town of Stockbridge.

Lot may be divided and sold.

SECTION 2. The board of supervisors of said town shall have power to divide said lot into such subdivisions as in their judgment may seem best, and they are hereby empowered to sell said lot or lots, and to execute to the purchaser thereof deeds of conveyance in fee simple: *provided*, that nothing in this act shall be construed so as to affect any legal light or claim which any person may have acquired to said lot, or any part thereof.

Proviso.

Notice of sale—proceeds to be paid into town treasury.

SECTION 3. The board of supervisors of said town shall sell said lot, or any subdivision thereof, to the highest bidder, after giving public notice of said sale, by advertising for three weeks in a newspaper printed in said county, and shall cause the money to be paid into the town treasury, for which money so paid the treasurer shall give the person paying the same a receipt, which will entitle the holder to a deed, as provided in section two of this act.

Moneys to be apportioned to school districts, &c.

SECTION 4. The town treasurer shall pay to the several school districts in the town, all the money so received, in proportion to the number of scholars in the several districts; and the treasurer shall in his annual settlement with the board, render an account of his doings, and should he not give a satisfactory account of
