

CHAPTER 94.

[Published March 9, 1865.]

AN ACT to amend chapter 419 of the general laws of 1864, entitled "an act to prevent the establishment of cemeteries and burial grounds within the limits of cities and villages."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Cemeteries not to be laid out within 200 rods of any building in addition to city or village.

SECTION 1. That chapter 419 of the general laws of 1864, be amended, by inserting after the word "erected," in the twelfth line of section one, and before the word "and," in the same line, the following: "or without the limits of such recorded plat of any city or village, or addition thereto, when the same shall be within two hundred rods of any lot or block in such city, village or addition, on which any building or buildings may then be erected."

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 95.

[Published March 9, 1865.]

AN ACT to construe and limit the provisions of chapter 252 of the general laws of 1862, entitled "an act to amend chapter 160 of the general laws of 1859, entitled "an act to prescribe and limit the rates of interest," and repealing chapter 202 of the general laws of 1860, amendatory thereof."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Construction.

SECTION 1. The amendment of chapter one hundred and sixty of the general laws of 1859, by chapter two hundred and fifty-two of the general laws of 1862, shall not be construed so as to contravene, conflict with or annul any of the provisions of chapter one hundred and fifty-one of the general laws of 1861.

Issue of bonds
legalized.

SECTION 2. All bonds heretofore issued or hereafter

to be issued by the city of Green Bay, under chapter one hundred and fifty-one of the general laws of 1861, bearing interest at eight per cent. per annum: *provided*, that the same have been or shall be issued for the purpose of taking up and canceling the old "plank road bonds" of said city, bearing eight per cent. interest per annum, are hereby declared to be lawful and binding, as if chapter two hundred and fifty-two of the general laws of the year 1862 had not been enacted.

SECTION 8. This act shall take effect and be in force from and after its passage.

CHAPTER 96.

[Published March 9, 1865.]

AN ACT to repeal chapter 22, general laws 1863, providing for the expenditure of the drainage fund in the town of Cold Spring, in Jefferson county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Chapter twenty-two of the general laws ~~Repeal.~~ of 1863, providing for the expenditure of the drainage fund in the town of Cold Spring, in Jefferson county, is hereby repealed.

SECTION 2. This act shall take effect and be in force from and after its passage.
