CHAPTER 144.

[Published May 1, 1866.]

AN ACT to amend chapter 109 of the general laws of 1864, entitled "an act to anthorize the county of Brown to issue bonds for the erection of county buildings."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Chapter 109 of the general laws of 1864, entitled "an act to authorize the county of Brown to issue bonds for the erection of county buildings," is hereby amended, by adding to the last line of section five the words, "Andrew Ried and E. Holmes Ellis are hereby continued as such commissioners, to co-operate with said county supervisors in the erection of said buildings, until the same are fully completed and accepted by them."

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 145.

[Published April 28, 1866.]

AN ACT to amend chapter 188 of the revised statutes, entitled "ot offenses cognizable before justices of the peace."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Willfully molesting public worship, &c.

SECTION 1. Section six of chapter 183 of the revised statutes, is hereby amended, so that it will read as follows: "Section 6. Every person who shall, at any time, willfully interrupt or molest any assembly of people met for the worship of God, or any member thereof, or any persons when meeting or met together for the performance of any duties enjoined on or appertaining to them as members of any religious society, or any wedding party, or other company or assembly of peaceable citizens, or for the recitation or performance of or instruction in vocal music, within the place of such

Commissioners te aid in the erection of county buildings. meeting or out of it, shall be punished by fine not exceeding twenty dollars, nor less than five dollars." SECTION 2. This act shall take effect and be in force

from and after its passage.

CHAPTER 146.

AN ACT to annex certain territory in the county of Ashland to the county of La Pointe, and to change the name of the county of La Pointe to that of Bayfield.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

SECTION 1. All the territory now in the county of Part of Ashland Ashland, known and described as townships forty-eight to La Pointe (48) and forty-nine (49,) of range (5) five west, and all of the fractional parts of townships forty-eight (48) and forty-nine (49,) of range four (4) west, situated on the west side of Long Island bay, are hereby detached from the county of Ashland, and annexed to the county of La Pointe.

SECTION 2. The name of the said county of La Nameof La Points Pointe is hereby changed to that of Bayfield, and the to that of Baysaid county of La Pointe shall hereafter be known and field. designated as the county of Bayfield.

SECTION 8. This act shall take effect and be in force from and after the first day of May, one thousand eight hundred and sixty-six.
