

fixed by this act; and all continuances and notices made or taken to any term of the circuit court of any of said counties, shall be deemed to be made or taken to the terms of such court as the same are fixed by this act; and all motions and other proceedings noticed to be heard at any regular term of such court, shall be allowed and considered to be noticed for hearing at the regular terms of this court, as the same are fixed by this act.

Repealed.

SECTION 2. All acts or parts of acts conflicting with the provisions of this act, are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

## CHAPTER 20.

[Published March 5, 1867.]

AN ACT to provide stationery and postage stamps for officers and employees of the senate, and also of the assembly.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Stationery and postage stamps to legislative officers and employees.

SECTION 1. The superintendent of public property is hereby directed to furnish to the chief clerk of the senate, the assistant clerk, clerks of the judiciary committees of the senate and assembly, clerk of the committee on claims, enrolling clerk, book-keeper, engrossing and transcribing clerks, sergeant-at-arms, assistant sergeant-at arms, postmaster, assistant postmaster, four door-keepers, porter and fireman, each stationery to the amount of fifteen dollars, and postage stamps each to the amount of ten dollars; also, to each messenger of the senate and messenger of the lieutenant governor, stationery to the amount of five dollars, and postage stamps to the amount of five dollars; and to the chief clerk of the assembly, assistant clerk, book-keeper, enrolling clerk, engrossing clerk, transcribing clerk, sergeant-at-arms and his assistants, the postmaster and his

assistant, two porters and five door-keepers, each stationery to the amount of fifteen dollars, and postage stamps to the amount of ten dollars each; also, to each messenger of the assembly, stationery to the amount of five dollars, and postage stamps to the amount of five dollars each.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 21.

[Published March 6, 1867.]

AN ACT to amend sections five, nine, ten and eleven of chapter 77 of the general laws of 1866, entitled "an act for the regulation of trade in certain cases," and in addition to said act.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Section five of chapter 77 of the general laws of 1866 is hereby amended, by adding the following words after the word "pounds," at the end of said section: "or in quarter-barrels containing fifty pounds, or in eighth-barrels or packages containing twenty-five pounds." Sec. 5 amended.

SECTION 2. Section nine of said act is hereby amended, by striking out all after the word "timber," in the third line of said section, and inserting the following words: "All barrels shall be well hooped with ten good hoops, all half-barrels or quarter-barrels with eight good hoops, and the one-eighth barrels or packages with six good hoops, and shall be made in a substantial and workmanlike manner." Sec. 9 amended.

SECTION 3. Section ten of chapter 77 aforesaid is hereby amended, by striking out all of said section, and inserting in lieu thereof the following words: "The fees for overhauling, inspecting, repacking and branding, including furnishing salt, shall be for each barrel, ninety cents; for each half barrel, fifty cents; for each quarter-barrel, thirty cents, and for each Fees for inspecting.
