

## CHAPTER 23.

[Published March 11, 1867.]

AN ACT to repeal chapter 354, general laws of 1864, entitled "an act authorizing the governor to take care of the sick and wounded soldiers of Wisconsin, and appropriating money out of the treasury for that purpose."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Chapter 354, general laws of 1864, en- Repealed.  
titled "an act authorizing the governor to take care of the sick and wounded soldiers of Wisconsin, and appropriating money out of the treasury for that purpose," is hereby repealed, and the secretary of state and treasurer are hereby directed to transfer the amount of money appropriated by said chapter, which remains unexpended, to the general fund.

SECTION 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 24.

[Published March 9, 1867.]

AN ACT to provide for a special election in the 5th senate district.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. A special election will be held at the several places provided by law for holding general elections in the 5th senate district, composed of the 1st, 2d, 6th, 7th and 9th wards in the city of Milwaukee, and the towns of Wauwatosa, Milwaukee and Granville, in the county of Milwaukee, on Wednesday, the 13th day of March, 1867, for the purpose of electing a state senator, to fill the vacancy occasioned by the death of the Hon. Jackson Hadley.

Election to be held March 13.

Copy of this act to be sent sheriff.

SECTION 2. It shall be the duty of the secretary of state, as soon as practicable after the passage of this act, to forward to the sheriff of Milwaukee county a certified copy of said act.

Notice of election.

SECTION 3. It shall be the duty of the sheriff of Milwaukee county, upon the receipt of the copy mentioned in section two of this act, immediately to cause notices of such election to be posted in three of the most public places in each town and ward in said senate district.

How election conducted.

SECTION 4. Said election shall be conducted and returns and canvass made as is now provided by law.

This act to be published.

SECTION 5. The secretary of state is hereby directed to forward a copy of this act to each of the daily papers published in the county of Milwaukee, and cause the same to be published in said papers each day until after said election.

SECTION 6. This act shall take effect and be in force from and after its passage.

## CHAPTER 25.

[Published March 11, 1867.]

AN ACT to submit to the people an amendment to section 21, article 4, of the constitution of the state of Wisconsin.

Preamble.

WHEREAS, The legislature of 1865, by a joint resolution, proposed and adopted an amendment to the constitution of this state, being in the following words: "*Resolved by the senate, the assembly concurring,* That section 21 of article 4 of the constitution of the state of Wisconsin be amended, so as to read as follows: 'Section 21. Each member of the legislature shall receive for his services three hundred and fifty dollars per annum, and ten cents for every mile he shall travel in going to and returning from the place of the meetings of the legislature, on the most usual route. In case of an extra session of the legislature, no additional compensation shall be allowed to any member thereof, either directly or indirectly,' " approved April 8th, 1865:
