GENERAL LAWS-CH. 60, 61.

CHAPTER 60.

[Published April 1, 1867.]

AN ACT to amend section one of chapter 68 of the general laws of 1866, entitled "an act to exempt property of the American bible society, and its auxiliaries and branches, from taxation."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. Add after the word "society," in the Exemption sixth line, "and real estate in value not exceeding ten thousand dollars, used and held for the purposes of the society," so that said section will read as follows: "That all bibles and testaments owned in this state by the American bible society, organized in the city of New York in the year 1816, or by any of its auxiliaries or branches, together with all other personal property necessary for the prosecution of their objects as a bible society, and real estate in value not exceeding ten thousand dollars, used and held for the purposes of the society, shall be exempt from all assessments and taxation whatever, except special taxes for the improvement of streets, or building or repair of sidewalks or gutters in front of the same."

SECTION 2. This act shall take effect and be in force

from and after its passage and publication.

CHAPTER 61.

[Published April 1, 1867.]

AN ACT to change the time of holding courts in the county of Crawford, in the fifth judicial circuit.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. That hereafter the general terms of General terms. the circuit court in and for the county of Crawford, in the fifth judicial circuit of this state, shall be held on the first Monday in June and the second Monday in November, in each year.

Return of process, &c.

Section 2. All writs, summons, process, indictments, recognizances and other proceedings made returnable to the terms now fixed by law, shall be returnable to the terms herein provided; and all adjournments, appearances, continuances, motions and notices of any proceedings in the circuit courts of said county, made or taken to the May term, 1867, of said court, shall be held and taken for the June term, 1867, of said court, as herein fixed and provided.

Repealed.

Section 3. All acts and parts of acts conflicting with the provisions of this act, are hereby repealed.

SECTION 4. This act shall take effect and be in force on and after its passage and publication.

CHAPTER 62.

[Published March 30, 1867.]

AN ACT to amend section 14 of chapter 112 of the revised statutes, entitled "of guardians and wards."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Service of notice of application son.

Section 14 of chapter 112 of the revis-Section 1. for guardianship ed statutes, entitled "of guardians and wards," is of insane perhereby amended, by adding the following: "provided, that whenever any such insane person shall be confined in the Wisconsin state hospital for the insane, such notice may be served upon the superintendent of such hospital, which notice so served shall be deemed sufficient in law; and if in the opinion of said superintendent it shall not be proper to remove such insane person, he shall certify that fact to the court, which shall be deemed a sufficient cause for not producing such insane person on the hearing."

This act shall take effect and be in force SECTION 2.
