

CHAPTER 147.

[Published April 8, 1872.]

AN ACT to provide for a list of the officers and employes of certain cities and counties, to be made annually by the city clerk of any such city, and the county clerk of any such county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The state printer shall, within ten days after the passage of this act, and annually thereafter within the first week of the year, furnish to the city clerk of each city, containing by the census of 1870, exceeding 8,500 inhabitants, and to the county clerk of each county within this state, containing by the said census, exceeding 60,000 inhabitants, blank forms for lists of the officers and employes of such city or county, which shall be substantially in the following form :

SECTION 2. Two blanks shall be furnished to each clerk of any such county for each of the following lists: 1st, of the board of supervisors; 2d, of the county officers; 3d, of the poor department, and of any other department established by law for such county; and two blanks shall be furnished to the clerk of any such city for a list of each of the following departments: 1st, of city council; 2d, of city officers; 3d, of the fire department; 4th, of the police department; 5th, of the board of public works, and of any department established by law for such city.

How distributed.

Shall fill out
blanks.

SECTION 3. It shall be the duty of the clerk of any such city and clerk of any such county to fill out the blanks furnished to him within two weeks after the receipt of the same by him in each year, and to obtain from each officer or employe of such city or county the necessary information to do so, and to keep one copy of each of such lists in his office for inspection, and to send a duplicate to the secretary of state.

Penalty for
refusal.

SECTION 4. The clerk of any such city and county who shall neglect to make out any such list or to keep the same for inspection and to send a duplicate to the secretary of state, and any officer or employe of any such city or county who shall refuse to give any information required to fill out the said lists, shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by fine in the sum of fifty dollars, or by imprisonment in the county jail for ten days, or both, in the discretion of any court having jurisdiction in such case.

SECTION 5. Any clerk or employe receiving any salary out of the treasury of any such city or county shall be included in said lists.

No compensa-
tion.

SECTION 6. No extra compensation shall be paid to any city or county clerk for such work provided for in this act.

SECTION 7. This act shall take effect and be in force from and after its passage.

CHAPTER 148.

AN ACT to amend chapter 130 of the general laws of 1868, entitled "an act to provide for the assessment of property for taxation, and the levy of taxes thereon."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section twenty of said chapter one hundred and thirty of the general laws of 1868, is hereby amended so as to read as follows: "Merchants'
