

CHAPTER 42.

[Published March 11, 1872.]

AN ACT relating to certain reclaimed lands.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Shall be owned
by persons
draining marsh

SECTION 1. So much of the bed of the marsh and pond in sections fourteen, twenty-three and twenty-six, township number sixteen north, range number twenty east of the fourth principal meridian in this state as shall be reclaimed by drawing the water therefrom, shall be owned and held in fee simple by the owners of the lands adjoining and bounded by said pond and marsh, and who may drain the same to the center or thread thereof. Division of said lands so reclaimed shall be made among said owners according to the rules of law.

SECTION 2. This act shall take effect and be in force from and after its passage.

CHAPTER 43.

[Published April 3, 1872.]

AN ACT requiring the county treasurers to make an annual statement of moneys paid to town treasurers, and for other purposes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Shall make certified statement of moneys received.

SECTION 1. It shall be the duty of the county treasurer of any county in this state, when so instructed to do by a standing resolution of the county board of supervisors of any such county, to make annually on the third Monday of March in each year, and forward to the town, village or city treasurers, a certified statement, showing the amount of money paid from the county treasury during the year next preceding, to the

treasurer of such town ; which statement shall specify the date of each payment, the amount of such payment, and the account upon which such payment is made,

SECTION 2. The town clerks of the several towns in this state shall, at the time a settlement is required by law to be made with the town treasurers, furnish to the town board, for their reference, the statement required to be made by section one of this act.

Shall furnish statement to town board.

SECTION 3. It shall not be lawful for any county treasurer to pay to the treasurer of any town, any money in his hands belonging to such town, from the third Monday of March until ten days after the annual town meeting of the same year, except upon the written order of the board of supervisors of such town.

When unlawful to pay over money.

SECTION 4. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 44.

[Published April 8, 1872.]

AN ACT to regulate the price for license to persons dealing in spirituous or intoxicating liquors in the several towns and incorporated villages in this state.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The price for license to each person dealing in spirituous or intoxicating liquors in the several towns and incorporated villages and cities in this state, shall not be less than twenty-five dollars or exceed one hundred dollars.

Price of license fixed.

SECTION 2. All acts and parts of acts inconsistent with the provisions of this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage.
