payment of current expenses at the Soldiers' Orphans' Home, until the first day of March, 1873.

To be drawn quarterly.

SECTION 2. All sums for current expenses shall be drawn from the treasury not oftener than quarterly in advance.

SECTION 3. This act shall take effect and be in force from and after its passage and publication, and shall be printed in the volume of general laws for the year 1872.

CHAPTER 88.

[Published March 28, 1872.]

AN ACT to appropriate a sum of money therein named for the erection of a center building, the purchase of land, fixtures and furniture, and for permanent improvements at the Northern Wisconsin Hospital for the Insans.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Appropriated.

Section 1. There is hereby appropriated, out of any money in the state treasury not otherwise appropriated, the sum of one hundred and thirty-two thousand dollars, for the following purposes, at the Northern Wisconsin Hospital for the Insane: To erect and complete the center building, ninety-one thousand eight hundred dollars; for the purchase of twenty acres of land, two thousand dollars; for providing means for lighting said hospital, and for the purchase of fixtures and furniture, thirty-one thousand five hundred dollars; for barn, outbuildings and for necessary fence and road making, six thousand seven hundred dollars.

May construct center building SECTION 2. The board of building commissioners appointed in pursuance of chapter thirty-nine of the general laws of 1870, are hereby authorized and empowered to construct, by contract, in the same manner as provided by sections seven, eight, nine, ten and eleven of said chapter, the center building, which shall contain the necessary and appropriate rooms for offices for the proper accommodation of resident officers and

their families, with the necessary conveniences of dining rooms, store rooms and kitchen, and also a chapel for the use of the patients, which shall be completed on or before January 1, 1873: provided, the cost shall not exceed the sum hereinbefore appropriated for that purpose. They are hereby authorized and empowered to make the purchases and improvements hereinbefore provided for, their accounts to be audited and paid, and their reports to be made as provided in sections four and five of chapter thirty-nine of the general laws of 1871.

Section 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 89.

AN ACT for locating and changing county seats.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Whenever any county shall be organ- May designate ized for county purposes, or whenever two or more county seat. counties may be by law united and organized as one county, it shall be the duty of the board of supervisors of such county, at the first regular meeting of said board, to designate some point in said county for the county seat, and the point so designated shall be and remain the county seat until removed in the manner hereinafter provided.

SECTION 2. Whenever one-third of the legal voters shall order elecof any county (to be determined by the poll list of the tion of voters. last previous general election held in such county, the names of which voters shall each appear on some one of the poll lists of said election,) shall present to the board of supervisors, a petition signed by them, asking a change of the county seat to some other place, such place to be designated in such petition, it shall be the duty of such board to submit the question of removal
