CHAPTER 155.

AN ACT to amend the charter of the city of Fort Howard.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section ten of chapter five of an act to Assessment incorporate the city of Fort Howard, approved March limited. 14, 1873, is hereby amended by adding at the end of said section, "and in addition thereto, a sum not exceeding four mills on the dollar valuation for ward purposes."

SECTION 2. Section four of chapter seven of said Street repairs. city charter is hereby so amended by adding at the end of said section: "And provided, further, that nothing herein contained shall be so construed as to include all necessary repairs on streets that have been already improved, but such repairs shall be a charge on the ward in which the same are performed."

SECTION 3. This act shall take effect and be in force

from and after its passage and publication.

CHAPFER 156.

AN ACT to amend section one of chapter one and section three of chapter five, and section three of chapter eight of chapter 337, of the private and local laws of 1871, entitled "an act to revise, consolidate and amend the act to incorporate the city of Prescott, and the several acts amendatory thereof."

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section one of chapter one of chap-Boundaries of ter 337 of the private and local laws of 1871, is cott. hereby amended, so as to read as follows: "Chapter 1. Section 1. All that district of country situated in the county of Pierce, and embraced in the following boundaries, to wit: Commencing on the Mississippi river, on the line running north and south through the center of the west half of section

fourteen (14), township twenty-six (26) north, of range twenty (20) west; thence north on said line through the center of the west half of sections fourteen and eleven, to the section line on the north side of said section eleven; thence west along the north line of sections eleven and ten, to the quarter post standing at the center of said section ten; thence north along the center line of section three (3), eighty rods; thence west, parallel with the north line of said section ten, to the center of lake St. Croix; thence down the center of lake St. Croix and the Mississippi river, to a point opposite the place of beginning; thence north to the place of beginning, shall be known and designated as the city of Prescott."

SECTION 2. This act shall take effect and be in

force from and after its passage.

CHAPTER 157.

AN ACT to appropriate to Lemuel Kromer a sum of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Apprepriated.

Section 1. There is hereby appropriated to Lemuel Kromer out of any money in the state treasury not otherwise appropriated, the sum of fifty-nine dollars and ten cents, for services as commissioner in taking testimony in the case of the state against P. O. Cassidy, late district attorney in and for the county of Wood.

SECTION 2. This act shall take effect and be in force

from and after its passage.
