AN ACT to provide for the trial of criminal actions in justices' courts.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The complaint may be in the following Form of comform :

STATE OF WISCONSIN, ---- COUNTY-88.

The State of Wisconsin) against (Name of accused.)

A. B., being duly sworn, says that on the ---- day of -----, in the year of 187--, at said county (name of the accused or alias) did (state the crime) against the peace and dignity of the state of Wisconsin.

Subscribed and sworn before me this — day of -C. D.

SECTION 2. Sections eleven to sections twenty-six sections apinclusive, of chapter 137, general laws of 1871, shall plicable in criminal trials be applicable in all criminal trials in courts held by injustices justices of the peace and in the examination of all courts. criminal cases by committing magistrates, and where the word "indictment" or "information" is used in said sections, the word "complaint" shall be substituted.

SECTION 3. This act shall take effect and be in force from and after its passage.

CHAPTER 248.

AN ACT to detach certain territory from the county of Barron and annex the same to the county of Burnett.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Townships thirty-seven, ranges ten, Towns annexed

to Burnett county. eleven, twelve, thirteen and fourteen west, are hereby detached from the county of Barron and annexed to the county of Burnett.

SECTION 4. This act shall take effect and be in full force from and after its passage.

AN ACT to appropriate a sum of money to the Soldiers' Orphans' Home for the current expenses for the year 1874.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Sum appropriated \$16,000.

SECTION 1. There is hereby appropriated out of any money in the general fund not otherwise appropriated, the sum of sixteen thousand dollars, in full for the payment of current expenses at the Soldiers' Orphans' Home for the year 1874.

How may be drawn. SECTION 2. All sums for current expenses shall be drawn from the treasury not oftener than quarterly. SECTION 3. This act shall take effect and be in force from and after its passage.

CHAPTER 250.

[Published March 24, 1874.]

AN ACT to provide for the improvement of certain parts of the west branch of Wolf river.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Authorized to improve river. SECTION 1. Any person, company, or association or corporation that may hereafter be created or organized under the laws of the state of Wisconsin, for the purpose (among other things) of improving the west branch of the Wolf river in Oconto county, Wisconsin, as hereinafter more particularly specified, that may improve the said west branch of the Wolf river from the north line of town twenty-eight (28), north of
