It is hereby made the duty of the treasurer of Shawano county, in addition to the other duties required of him by law, to maintain and keep up the abstract of tax sales in his office by noting redemptions that are made or deeds that are executed for taxes: provided, that he shall not receive any fees therefor other than his salary fixed by law for discharging the duties of county treasurer.
